## SPECIAL MEETING OF THE SMITHVILLE TOWN BOARD November 22, 2010

A special meeting of the Smithville Town Board was called to order at 6pm Monday November 22, 2010 by Supervisor Allan Johnson. The meeting was called to discuss late minute budget questions by some members of the Town Board. Present were the following:

Enforcement Officer Neal Root has a new Questionnaire he would like to distribute to property owners requesting a building permit application. Before he signs their building permit, he would like them to sign the questionnaire which asks questions about water sources and working septic systems on the property. Board members reviewed the questionnaire and thought this would benefit the Enforcement Officers position in signing the building permit.

Town Clerk Owens requested permission to attend a Town Clerk's Association meeting having to do with accounting, dog licensing and Town Clerks on Dec. 6<sup>th</sup> in Virgil. The cost is \$25.00. The following resolution was brought forth:

On a motion by Councilwoman Vanderweyde, 2<sup>nd</sup> by Councilman Connelly, the following resolution was ADOPTED.

RESOLVED to allow Town Clerk Owens to attend the Town Clerk's Association meeting Dec. 6<sup>th</sup> at a cost of \$25.00.

Supervisor Johnson called attention to the purpose of the special meeting to discuss, before adoption, the 2011 Preliminary Budget, and specifically whether to allow 1.5% or 3% raises to certain line item salaries or to leave "as is" in the original Preliminary Budget. Board members were given data sheets on the impact of a 1.5% increase in those specific line items and what it would do to the bottom line of the proposed Budget.

Councilman Connelly and Councilwoman Vanderweyde felt 3% increases should be allowed for all line item salaries, with a few exceptions. Councilman Schultes concurred. Supervisor Johnson used an Excel spreadsheet on laptop to change the figures and reported an overall minimal impact. Supervisor

Johnson then recommended to Board members the sales tax revenue for next year could be modified upwards as new figures recently released suggested a rise in sales for Chenango County. Board members asked Supervisor Johnson to revise the sales tax revenue \$3,000. upward. The total figures revised the Highway side to \$6.34 p/th (\$5.62 p/th in 2010), and the General to \$.92 p/th (\$1.06 p/th in 2010) with additional impacts for each Fire District.

Board members were in agreement with these figures as presented by Supervisor Johnson. The following Resolution was brought forth:
