Supervisor Johnson reminded Board members there is \$80,000. in surplus monies in the Highway fund for 2009; This could be put into the TB fund or the Highway Equipment fund.

The possibility of finding grants and/or grant writers for funding the new Town Barn was discussed.

The 1989 FORD Ranger has been purchased, but not removed yet; no one has heard from the person purchasing the fire truck.

Highway Sup't Kinney has spoken with Michael Cerwinski about his bid for the FORD F350 p/u truck. Mr. Cerwinski had put in a bid of \$885. for the truck, but had recently raised it to \$1100. after the Dec. 21<sup>st</sup> Town Board meeting. The Town Board had wanted to see the truck sold for \$1500. Highway Sup't Kinney received another bid for the truck from Todd Bellis of Whitney Point for \$1300. Board members discussed the option of accepting the new highest bid or waiting. A new Resolution was brought forth.
