The position will not be advertised immediately. It was suggested to contact the Dog Control Officer for the Town of German. Supervisor Johnson will make some inquiries.

NB3: **Presbyterian Church Group/Rental of Community Center**. Jill Schaeffer, moderator of the Presbytery, gave thanks to the Town for their help in the Church's time of need. Diane Merrill, Session leader, asked the Town Board if they would be allowed to continue holding Sunday worship services at the Community Center for a few more months. They are in the building for about 3 hours each Sunday and will do what is necessary to keep the building clean after usage. The Church has paid a yearly Group Rental Fee to the Town which is good until 8/31/2010. The Church usually rents the Community Center on a yearly basis to help with a place for dinners, etc.

Mindy Eldred of the Smithville Valley Grange asked if there was an issue with having Religion within this building. She said most groups have a religious background, but that it should not interfere with using the Community Center.

The Town Board said they would have no difficulty allowing the Church to use the Community Center for their Church services. This was put to Resolution:

RESOLVED to honor the yearly agreement with the 1^{st} Presbyterian Church and to allow them to continue meeting in the Community Center.

NB4: Comments from Genegantslet Fire Chief Bob Whitmore:

- wished to thank everyone for attending the groundbreaking for the new fire station.
- The brand new fire truck is in service.

- The Fire Co. is working on the 2011 Budget and insurance and should have figures by the 1st part of next month. Supervisor Johnson said he will welcome the figures to put into a preliminary Budget.
- Asked if the Highway Dept. can sand/salt the new Fire Station driveway/parking area for inclement weather?
- Suggested fire hydrants would be of particular help in the hamlet. There are 5 "dry" hydrants in the Town which allow for easier access to water in times of need.
- Discussion has continued about requesting to service Smithville Center through the Genegantslet Fire Co. The Fire Co. now has the capacity to reach the Smithville Center area.
- Asked if there could be a yard goods compost area across from the Town Barn where there used to be a Town Dump? Supervisor Johnson said he would look into the matter.

NB5: **Resignation of Justice Lenga**: Justice Bill Lenga has written a letter of resignation effective December 31, 2011. Town Clerk Owens indicated a resignation from a Justice cannot be more than 90 days from the date filed, therefore, the effective date of the resignation will be December 18, 2010. The following resolution was brought forth.

RESOLVED to accept the resignation of Justice Bill Lenga to be effective December 18, 2010, with deep appreciation for his service rendered to the Town of Smithville.

Discussion: There was much discussion on what to do for 2011. Town Clerk Owens had spoken with the Association of Towns who verbally gave some different options for the Board to consider. The Town Board could appoint another Justice for 2011, with the Election of 2011 deciding who would be in the 4yr. position 2012-2015; an Attorney could be appointed to fill the vacancy until 12/31/2011; another Justice from a neighboring community could be appointed to come and assist for the remainder of the term; the Town Board could decide to drop from 2 Justices to 1 through permissive referendum, or the Town Board could not appoint anyone to the vacant position and the position would be filled at the next election (2011). Councilwoman Mohr suggested someone talk with Justice Braman to see what his feelings are on the subject of replacement. Supervisor Johnson will ask questions/opinions/options of various individuals.

NB6: **Neal Pease and Robert Eldred of Enggaard Rd** were recognized by Supervisor Johnson. They came to complain about the condition of Enggaard Rd: pot holes, poor ditches, pavement is nearly gone, no shoulders. They had been told it was to be paved but that has not happened yet. Highway Sup't Bruce Kinney was not present to comment on the situation. Supervisor Johnson will contact Hwy Supt Kinney to find out what the delay has been.

NB7: Louis Merlino, resident of Buckley Hollow Rd. was recognized by Supervisor Johnson He had 2 concerns:

- 1.) He would like to see a cable co. provide service on Buckley Hollow Rd.; Time Warner Cable can't come into Smithville because Haefle TV, which services only the hamlet, has a contract with Smithville.
- 2.) Buckley Hollow Rd. is marked for improvement but the loggers have taken out much of the road. Road needs to be redone NOT patched. Loggers should be made to pay for road damage. Supervisor Johnson will check into these problems.

OLD BUSINESS (updates since last meeting)

OB1: Dog License updates: Town Clerk Owens reviewed with Board members information she has tabulated with respect to dog license income/expenses for 2009 and the proposed rates for 2011. The newly formed Chenango County Town Clerk's Assoc., will be meeting with the Chenango County Board of Supervisors Ag, Grounds & Building Committee to discuss with them the proposal to standardize County dog license rates in a County local law for all municipalities. The rates have been tentatively set at \$8.50 for spayed/neutered dogs and \$15.00 for unsprayed/unneutered dogs.

OB2: Flood Damage Prevention Local Law: The DEC offices in Albany and Kirkwood have been sent copies of the proposed Flood Damage Prevention Local Law recommended by Att'y Monaco. The Town Board will need to set a date for the Public Hearing of proposed local law. Supervisor Johnson recommended setting the date for Oct. 18th, which will be the date of the next Town Board meeting.

MINUTES APPROVAL: The minutes of the August 16th meeting were reviewed. A motion to approve these minutes was made by Councilwoman Vanderweyde, 2nd by Councilman/Schultes. All 4 Board members, Mohr, Schultes, Vanderweyde and Johnson were in favor. Councilman Connelly absent. Motion passed.

- R1.) Planning Board: Comprehensive plan still being worked on
- R2.) Assessor: no report. Supervisor Johnson read the latest sales report which indicated 11 sales in the Town of Smithville from 2009/2010. The sale price of each parcel in respect to its assessed valuation is considerably higher on most of the parcels. Supervisor Johnson wanted to note these discrepancies and felt the Assessor was still interested in doing a re-val next year.
 - R3.) Enforcement Officer: report submitted. County building permit report submitted.
 - R4.) Justice: no report
 - R5.) DCO: report submitted
 - R6.) Attorney: report submitted
 - R7.) Smithville Day Committee: no report
 - R8.) Community Center: no report

- R10) Town Clerk: report submitted. Board members asked the Groundskeeper to estimate cost of replacing back door of TC office, which is warped and leaks during rainy weather.
 - R11) Highway: report submitted. Board members questioned the warranty on Case wheel loader.
- R12) Supervisor's/Bookkeeper Report: report submitted. A motion to approve the Supervisor's/Bookkeeper's report was mad by Councilwoman Mohr, 2nd by Councilwoman Vanderweyde. All 4 Board members, Mohr, Schultes, Vanderweyde and Johnson were in favor. Councilman Connelly absent. Motion passed.

WARRANTS

General Warrant # 9, Vouchers # 133-146 in the amount of\$2408.69, and #123 to the SPCA in the amount of \$150. from last month was submitted for payment. Board members had questioned # 123 to the SPCA and asked to reserve payment until the bill could be investigated further. Supervisor Johnson was satisfied the bill was genuine. A motion was made by Councilwoman Mohr, 2nd by Councilwoman Vanderweyde to pay bills # 133-146, and # 123. All four Board members present, Vanderweyde, Schultes, Johnson were in favor, motion carried. Councilman Connelly was absent.

Highway Warrant # 8, Vouchers #126-141, in the amount of \$64,693.15 was submitted for payment. Board members questioned # 142 to Monroe Tractor for \$1597.19 and asked to reserve payment pending further explanation. A motion to accept and pay these bills was made by Councilwoman Mohr, 2nd by Councilman Schultes. All four Board members present, Vanderweyde, Schultes, Johnson were in favor, motion carried. Board member Connelly was absent.

There were no JRC bills.

Bookkeeper Smith asked if the reports she provides for Board members could be emailed to them as opposed to being copied. Town Clerk Owens also asked if the Board material for the Town Board meetings could be put together in 1 packet and emailed. This would save much in time, paper and toner. Board members were willing to try it.
