2. **Disposition of Voting Machines**: There is an immediate need for space for Grange and Church (via Mindy Eldred). Since it had already been discussed to sell the old voting machines

if the Historical Society did not want to save one, the Highway Dept. should get rid of them/sell them for scrap metal.

3. **Deputy Highway Sup't Discussion:** Highway Committee members feel there is a necessity to appoint a Deputy Highway Sup't to act when the Highway Sup't is not present. A Town Board may establish a Deputy Sup't position and may appoint someone to act. It will become part of the contract for the Labor Union. Supervisor Johnson will call other Towns with labor union contracts and will see how they have handled the position and the language in the contract.

#### **OLD BUSINESS**

- 1.) Dog Local Law—problem with effective date. Effective date can be as early as the following day the Public Hearing and after the Board takes action.
  - 2.) Dog monies received can only be used for dog business. Town Clerk Owens proposed to open a checking account at Citizens Bank for doing dog business. The account will be in the Town Supervisor and Town Clerk's name.
  - 3.) **Desk for Justice**: It has been proposed to replace the Assessor's 2<sup>nd</sup> desk with a workspace to share with the Justice. Town Clerk Owens suggested a figure of \$1,000. to create the work space. Board members suggested the possibility of using monies from the building fund to pay for it. The following RESOLUTION was brought forth.

## RESOLUTION # 2 (2011): TO PLACE A CAP OF \$1,000. EXPENDITURE FOR DESK

On a motion by Councilman Connelly,  $2^{nd}$  by Councilwoman Vanderweyde, the following Resolution was ADOPTED.

RESOLVED to place a cap of \$1,000. for the expenditure of a desk/working space for the Justice.

- 4.) **Town Barn furnace:** 2 quotes have been received by Councilman Connelly for replacing the Town Barn furnace; a 3<sup>rd</sup> quote will be forthcoming.
- \* Mirabito: \$4,920. with existing ductwork, or \$9,225. with new ductwork
- \* Blue Ox: \$6,875. with adding to ductwork already in place
- \* Reese-Marshall: not yet quoted, but will add more ductwork

After the 3<sup>rd</sup> quote comes in, Supervisor Johnson will get together with Highway Committee Board members Chuck Schultes and Roger Connelly to make a decision. The following RESOLUTION was brought forth:
