#### AWARD OF FUEL BID

The Board discussed the bids noting the bid for '87 octane unleaded gas was requested last month to be withheld from the legal ad as the Highway employees are purchasing this product on the road. Town Clerk Owens was not present at the April meeting and did not receive the message. Both bids for '87 octane unleaded gas were then disregarded.

All fixed price bids for the remaining products except for USLK were bid lower by Mirabito. Board members and the Hwy Sup't felt it would be more consistent to use the same provider for USLD and USLK so the fixed price bids for all remaining fuel products were then awarded to Mirabito.

NB1) Series of Public Hearings in Chenango County with regard to State mandated shared services. June  $1^{st}$ @ noon and 5:30pm; June  $12^{th}$  @ noon. The County has responsibility to come up with a plan for shared services. There is no penalty for not participating in shared services at this time.

OLD BUSINESS (UPDATES IF ANY)

OB1) information on speed limit signs for hamlet/Town signs: Flashing speed limit signs are ready to be installed, probably by the end of this week or next.

OB2) status of the Communications Tower: This is up and running. Town-wide coverage is not 100% but has made gains over the previous system. It was suggested to communicate with the Union that these items, which were part of the negotiations, have been taken care of.

OB3) Cowles Cemetery discussion w/Att'y Dave Berger. Cowles Cemetery, classified as abandoned and having its own tax map #, had a burial in February this year, previously two other burials in the last 20 years. By a 1958 deed from Harold Cowles to John and Myrtle Warren, the cemetery was excepted from the purchase so Att'y Berger feels the Cowles family has retained ownership of the cemetery. Town Law says there are 3 classes of a burial ground, 1 of which says the title of the cemetery can be vested in the Town if outside the legal 14 yr period; but because there have been burials in the cemetery since its abandonment, the Town is not legally required to be vested in it. Questions were: who will maintain the cemetery and who will control who is buried there? Is the cemetery considered private? The Att'y will write a letter to the Brown/Cowles family and also the current owner of the surrounding property explaining the ownership belongs to the Cowles family and/or its descendents, because of the 1958 deed, and the family will be asked to maintain it. It will be considered a private cemetery and permission for burials would have to be requested from the family.

There are 7 other cemeteries in the Town of Smithville that are classified abandoned that have their own tax map #'s.

OB4) **Town Road Agreement w/Att'y**. The Att'y reviewed the draft copy of the proposed Road Use Agreement. This Agreement should be considered as a Local Law and would be under the requirement to be subject to a Public Hearing. He suggested restrictions in the proposed Local Law to repair roads for timber processing, but the law has to have an enforcement mechanism, either word of mouth or by web access; perhaps also a Post Bond procedure and insurance requirements. The current Draft Agreement says the Hwy Sup't and Town Clerk are involved in the Enforcement/Accounting process. The two biggest concerns are logging and moving trailers/manufactured homes.

Bob Brooks, Planning Board member: With regard to the Road Use Agreement, the bidding process for timber doesn't guarantee a purchase. He said the Planning Board's main idea was to start small and work into something larger

The Planning Board can put penalty clause in the agreement but the Planning Board may not support a penalty. The Town Board felt there should be a penalty for not getting a permit. Planning Board will review the Road Use Agreement.

OB5) Status of '97 MACK truck and purchase of used truck from the Town of Sherburne: The Town of Pharsalia would like to buy the '97 Mack which will be sold as "salvage". Pharsalia is checking to see if it can be insured. Truck will be sold for a net of \$5,000.

The Town of Sherburne has offered Smithville a truck for \$75,000. that is next on their list to be rotated out. The 2010 International is ready to go, is in good shape, and comes with plow, and wing; Sherburne trucks are replaced every 6 years. Pictures of the proposed truck were reviewed. The money

to purchase the Sherburne truck would come from the \$25,000 insurance co. settlement for the salvaged truck + \$34,000. from the New Equipment account DA5130.2; an additional \$10,350 from Interfund Transfer DA9950.9, the remaining from Highway Savings. \$16,000. (NBT account 8001634217). Councilman Whitmore recommended buying the truck.
