MINUTES OF THE SMITHVLLE TOWN BOARD SPECIAL MEETING FEBRUARY 26, 2022

A special meeting of the Smithville Town Board was called to order at 1pm by Supervisor Cammarata.

The reason for the meeting was to discuss the purchase or lease of a new Loader for the Town. The older Loader, a 2003 Case model is not responding to mechanic work. A loader at this time of year is used to load sand and salt onto the trucks for distribution on Town roads.

Also:

Town Board members were presented with 2 purchase offers

2 lease agreement proposals from Real Lease (CASE) and 1 purchase offer from Monroe Tractor/Smith Dealership,

6 Equipment Dr., Binghamton NY 13904

2 lease agreement proposals from the Case dealer, 55 Industrial Dr., Binghamton NY 13904

In reviewing the proposals and offers, the following comments were offered:

Supervisor Cammarata indicated the trade in value for the current (Case) machine is lower on the CAT proposals than the CASE proposals. CHIPS monies can be used to help purchase new equipment. A trade in value after 1 yr of the CAT machine would result in a value of \$125K. Can also trade again after 3 years. The CAT lease option includes servicing; extended warranties are available for both machines. CAT has 1 machine which will probably not be ready until May 2022.

Hwy Sup't Witkowski prefers the CASE machine but the CAT is a better deal and will hold the resale better than the CASE.

Councilman Butler said the cheapest is Option1 on the CAT model with a 4 yr lease and our loader for trade. Councilman Whitmore suggested leasing for 1 year to see if the Town likes the machine and the lease.

After continue discussion Board members made the following Resolution to lease the CAT machine for 4 years w/option to purchase.

RESOLVED to lease for a 4 yr period, one CAT Loader, model # 938, 3V from Milton CAT. Binghamton NY with a trade of the current Town CASE machine for \$52K, an interest rate of 3.16%, and 4 annual payments of \$45,266.44. There will be an option to purchase the machine at the end of the lease. The lease will also include servicing.

OTHER:

Supervisor Cammarata indicated 5 other Towns had hired an Attorney to help them negotiate the ARPA funds and had been successful. The Att'y had completed a loss ratio for the Town and had filed a 6 page report when due. The other Towns are completing projects such as a radio system, a telephone system, decorations, new TB roof and a handicapped door. Two firms have been recommended: LaBerge an MRB Group. Supervisor Cammarata feels hiring one of these firms for the fee of \$3,000. would be beneficial.

Councilman Butler said his office has used LaBerge and has been pleased with them. Board members decided to move in this direction.
